The BSP Manager will contact you directly concerning the provision of validation equipment to validate your supply of BSP Standard Traffic Documents. With regard to those airlines that do not participate in the BSP, their traffic documents will need to be validated in a different manner to the Standard BSP Traffic Documents. You will need to acquire a validating machine in accordance with their specifications. Any of the non-BSP carriers supplying you with their own dedicated traffic documents should be able to advice you in this respect.

Your specific attention is drawn to the rules concerning minimum security standards (Resolution 824, Section 5). These stipulate that you must not hold more than 1 working week's supply of traffic documents on the premises. They should be stored in the safe when not in use and should never leave the Approved Location. The reserve supply may be held in a safety deposit box or in a bank vault. Validators and CIPs must be stored under lock and key separate from ticket stocks.

The duly signed duplicate copy of your IATA Passenger Sales Agency Agreement will be mailed to you from the Agency Administrator's Office in Geneva. May I remind you that the IATA Agreement will only become effective between your agency and individual member airlines after such airlines have duly appointed your agency to represent them (Article (1) of the Agreement refers).

In accordance with the provisions of the Passenger Sales Agency Rules, please ensure that you notify this office prior to the effective date of any change, which may take place within your
